The Spotsylvania County Crime Solvers is managed by a Board of Directors comprised of volunteer residents of our community who oversee the operations of the program and approves the rewards to be paid. Additionally, our organization is a not-for-profit 501(c)3 charitable corporation that exists through the generous contributions from sponsors like you, area businesses, local civic organizations, and citizens. Our Federal ID is # 54-13353756.

Last year, we celebrated our 35th year of providing our citizens of Spotsylvania County with a means to get involved in fighting crime and making our community a bit safer. How does all of this work? Crime Solvers offers cash rewards and anonymity to people who provide information that results in the arrest or resolution of any unsolved crime, recovery of stolen property, or seizure of illegal drugs. Key to our success is confidentiality and callers not being required to testify in court. If a caller's information results in the arrest or resolution of an unsolved crime, the caller is given arrangements to receive his or her reward in CASH while preserving his or her anonymity. To make all of this work we require financial support to pay operation costs (i.e., Tip Phone Line, P3 App, P3 website and our website) to better enable our citizens to assist the Spotsylvania Sheriff's Office in solving crimes.
